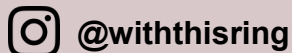

Exhibitor Terms & Conditions

Please read and initial the following, as your acceptance acknowledgement of the exhibitor terms and conditions required of all With This Ring... Bridal Gala exhibitors:

- _____ 1. Booth cancellations must be done in writing and received 30 days prior to the show date. In the event of such cancellation the amount paid will be refunded less a \$50 administration fee. No refunds will be made for cancellations less than 30 days from the date of the show. Westerner Park reserves the right to re-rent any cancelled space.
- _____ 2. Every effort will be made to meet requested booth locations, subject to availability. Westerner Park reserves the right to determine the final placement of any exhibitor in the show regardless of location requests. Booth locations will not be re-released until arrival.
- _____ 3. Westerner Park agrees to provide the Exhibitor with a standard booth and side railings as required and provided prior to the move-in of the show.
- _____ 4. Signed contracts along with full payment are due no later than 30 days prior to the show.
- _____ 5. Each vendor must provide a door prize of a minimum \$50 retail value, as part of their participation in the show.
- _____ 6. Only registered exhibitors are allowed to promote their products and services at this show. Outside and/or non-registered products and businesses are not permitted to be displayed, distributed, or marketed in any way in the show.
- _____ 7. Westerner Park does not provide exhibitors with exclusivity to any one particular product or service unless specifically negotiated in writing through sponsorship.
- _____ 8. Westerner Park reserves the right at any time to alter or remove exhibitors or any part thereof, including printed materials, product, signs, lights or sound, and to expel Exhibitors or their personnel if, in Westerner Park's opinion, their conduct or presentation is objectionable to other Show participants.
- _____ 9. The exhibitor agrees to hold harmless Westerner Park, its agents, servants, staff, students, volunteers and sponsors, from and against any or all loss claims including accidents, theft, damage, injury or death regardless of action in relation to the activities arising from the production and promotion of the With This Ring...Bridal Gala.

- _____ 15. The Exhibitor is responsible for the placement and cost of insurance related to his participation in the Show listing Westerner Park as additionally insured. A copy is to be provided to Westerner Park prior to move in.
- _____ 16. The Exhibitor agrees that no display may be dismantled or goods removed during the entire run of the Show but must remain intact until after the show has completed on the last day. The Exhibitor also agrees to remove his exhibit, equipment and display items from the Show building by the final move-out time limit, or in the event of failure to do so, the Exhibitor agrees to pay for such additional costs as may be incurred.
